That the Court enter an order compelling Plaintiff/Defendant to serve responses to Plaintiff's/Defendant's First Request for Production of Documents and to Plaintiff's/Defendant's First Set of Interrogatories to Plaintiff/Defendant, and compelling Plaintiff/Defendant to pay Plaintiff's/Defendant's costs and attorney fees incurred in obtaining said order;
- 2. Or, in the alternative, that the Court impose other appropriate sanctions upon Plaintiff/Defendant, together with a requirement that Plaintiff/Defendant pay Plaintiff's/Defendant's costs and attorney fees incurred in obtaining the order; and
- 3. That the Court grant unto Plaintiff/Defendant such other and further relief as the Court deems just and proper.
