You always deserve the truth from your attorney. Keep in mind the following points that they should be upfront about.

1. *Based on your case, you might not achieve the outcome you desire*

No matter how talented or experienced your attorney may be, they can't change the law. A talented attorney will make the best arguments on your behalf, but if the law simply doesn't allow for the outcome you seek, your attorney must be honest about that reality. Billing you for hours spent seeking an outcome that is impossible is unfair to you, and a waste of your valuable time and money.

2. *Divorce isn't always fair*

Most of us want to view the law as being impartial, blind, and a perfect balancing scale of justice. Unfortunately, this isn't always reality. While judges, attorneys, and the parties involved may seek a result that seems fair, the truth of the matter is that you may end up disappointed with some aspect of the final outcome of your settlement. There is often a disparity between what feels fair based on your own personal knowledge of the relationship, and your personal history, and what the law determines is fair.



3. *We don't really have much experience in this area of the law*

The truth of the matter is that not every attorney who agrees to take on a family law case necessarily has much experience in the actual practice of divorce and family law. While it is unfortunate, there are some attorneys who will take a case simply for the financial benefit of it – whether or not they truly have a thorough understanding of family law, or the experience necessary to achieve positive results on your behalf. That's why it is critical to make sure you choose an attorney with favorable references and a proven track records of success.

4. *We accomplish more through cooperation than aggression*

Many attorneys will try to portray themselves as very aggressive, cutthroat litigators who will stop at nothing in winning for their clients at all costs, and who will not shy away from a fight. Many of these attorneys portray themselves that way because they feel that this sort of representation is what clients expect. The reality of divorce litigation, however, is that methods of alternative dispute resolution like mediation, attorney-led settlement negotiations, and collaborative law, where the attorneys treat one another respectfully and work amicably toward solutions that fit the needs of both spouses, accomplishes much more and is more effective in the long run.

5. *Adults should act their age*

Any attorney who regularly practices family law understands that divorce is a very emotional experience.
